A FEMALE VETERANS VILLAGE IS BEING BUILT IN COCOA, FL. TWO HOMES HAVE BEEN COMPLETED WITH FOUR MORE IN PROCESS. THE SIX HOMES IN THE VILLAGE WILL BE COMPLETED BY FY 2023. HABITAT OF BREVARD DIVERTED 747,863 POUNDS OF WASTE FROM THE LANDFILL. TWENTY REPAIR PROJECTS AND FIVE VETERANS REPAIRS WERE UNDERWAY OR COMPLETED AS WELL.
